

## **BCSN Give Back – Official Poll Rules – December 2017**

1. **TIMING:** The Promotion begins at 9:00 AM Eastern Time on Monday, November 13, 2017 and ends at 11:30 p.m. Eastern Time Sunday, November 19, 2017. ("Promotion Period").
2. **HOW TO VOTE :** Promotion winners will be selected by a panel of four (4) judges selected by Buckeye/FrontPath Health Coalition and by the results of the online poll, with the determination of **the judges and the determination of the poll to be given equal weight**. As to the "Give Back" program, judges will consider the financial need, potential impact of the award, practicality of the request, and the overall quality of the written essay and application. **The school with the highest combined percentage from the online poll and the judges vote will win.**

To participate in the online polling, complete and submit a poll through BCSN.tv. All fields on the online poll are required. **There is a limit of one (1) vote per device per 24 hour period.** Use of agencies or robotic, repetitive, programmed or similar entry methods is prohibited. Any duplicate votes are grounds for disqualification. All entrants agree to abide by these Official Rules for the Promotion (the "Official Rules") and to conform to all federal, state, and local laws. In the event of a dispute, the "entrant" for e-mail entries is the person in whose name the e-mail account is held. Sponsor is not responsible for lost, late, incomplete, altered, postage due or misdirected votes, for failed, partial or garbled computer transmissions, or for technical failures of any kind, including, but not limited to electronic malfunctioning of any network, hardware, or software which may limit an entrant's ability to participate in this Promotion.
